What data do we collect?

How do we store your data?

Norrköping Studios securely stores your data at One.com as backups and they are also the host of our website. We also have an own database where we store our Branschregister. This is setup on a NAS, which is provided by Norrköping Studios and is located at Norrköping Studios offices. The NAS is offline outwards but can be accessed through Norrköping Studios own internal network. We have a Network Access Protection which is integrated within the NAS.

Norrköping Studios will keep your data which is listed under "What do we collect" for as long as you Norrköping Studios is active and work within the Swedish film business. Once this time period has expired, we will delete your data by formatting the NAS and then drill holes in the HDD.

The right to access - You have the right to request Norrköping Studios for copies of your personal data. We may charge you a small fee for this service.

The right to rectification - You have the right to request that Norrköping Studios correct any information you believe is inaccurate. You also have the right to request Norrköping Studios to complete information you believe is incomplete.

The right to erasure - You have the right to request that Norrköping Studios erase your personal data, under certain conditions.

The right to restrict processing - You have the right to request that Norrköping Studios restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to Norrköping Studios processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that Norrköping Studios transfer the data that we have collected to another organization, or directly to you, under certain conditions.
